Justin reported fair setup is underway and all planning is coming together in preparation of the June 4^{th} opening.

- The master plan update relative to emergency resiliency has been received. The next phase will be to adopt a new master plan to present to the Board of Supervisors.
- Staff is working diligently to book upcoming events and the current sales and event look ahead report was reviewed.
- She is working with Brian regarding City of San Mateo police and fire services.
- The budget process will begin following the Fair.
- New main gate and Delaware Street signage will be installed after the Fair along with the new parking lot shade structure.
